Errors and Omissions,

19 November 1998: In Hansard's copy of the Hansard, the pagination is as follows: 116, 117, 118, 118, 120, 121. Hansard's edition is missing page 119, and page 118 is duplicated in its place. Neither the Coles Library's copy, nor the Clerk's copy have this error. There are no page sequence problems with the online edition. There is, however, the normal discrepancy between the Green Bound edition pagination and the online pagination that occurs throughout the entire Hansard text.

19 November 1998: On page 123 during the Question Period topic "Hospital Bed Utilization Study", hon. Mike Currie is incorrectly listed as speaking to the question. It should have been hon. Mildred Dover.

14 April 1999: On page 1431 during the Question Period topic "Loan to Gordon Lank's Hog Operation", hon. Pat Mella is incorrectly listed as speaking to the question. It should have been hon. Robert Morrissey.

20 April 1999: On page 1612 in Statements by Ministers, "National Organ and Tissue Donor Awareness Week" is incorrectly attributed to hon. Pat Mella, when it should be hon. Mildred Dover.

30 April 1999: It initially appears that there are twenty-eight pages missing 2081-2109 in the Green Bound version of Hansard. What has actually occurred is that the pagination goes from 2080-2110, but the following page is 2109, continuing in descending order until 2081, at which point normal pagination resumes and 2081 is followed by 2111. This error only occurs in the bound edition: there are no page sequence problems with the online edition. There is, however, the normal discrepancy between the Green Bound edition pagination and the online pagination that occurs throughout the entire Hansard text.

6 May 1999: In Hansard's copy of the Hansard, 6 May 1999, there is an error that commences on page 2290, where the page that follows is 2320. From page 2320, the pagination continues backwards, until page 2291 is reached, at which point, the following page is 2251. What follows is a repetition of pages because the volume continues from page 2251 through to 2290, at which point the error reoccurs and the following page is 2320. Once again, 2320 follows in decreasing order to page 2291, at which point normal pagination resumes on page 2321. In Hansard's copy there is a duplication of 70 pages.

In comparing the different editions of Hansard that are easily accessible, the initial error is found in the Clerk's copy of Hansard: Page 2290 is followed by page 2320 and then the pages follow in descending order to page 2291 and normal pagination resumes on page 2321. There is no duplication of pages.

This is to be contrasted with the Coles Library's copy of Hansard, where the pages go

from 2250 to 2321, and they are simply missing 70 pages.

This error only occurs in the bound edition: there are no page sequence problems with the online edition. There is, however, the normal discrepancy between the Green Bound edition pagination and the online pagination that occurs throughout the entire Hansard text.

- 7 May 1999:** On page 2338 during the Question Period topic “Brudenell II Golf Course” Keith Milligan is listed as speaking twice, when it was really Kevin MacAdam who should have been listed as speaking in the first instance.
- 2 June 1999:** The entire day of 2 June 1999 is missing from the bound version of the Clerk’s Journal. There are no page numbers missing in the journal to indicate that pages were omitted from the bound version, there is simply the absence of 2 June 1999. There are no problems with Hansard on this date. Everything proceeded normally.
- 3 June 1999:** In Hansard’s copy of the Hansard, the pagination is as follows: 3369, 3370, 3371, 3370, 3373. Hansard’s edition is missing page 3372, and page 3370 is duplicated in its place. Neither the Coles Library’s copy, nor the Clerk’s copy have this error. There are no page sequence problems with the online edition. There is, however, the normal discrepancy between the Green Bound edition pagination and the online pagination that occurs throughout the entire Hansard text.
