Pursuant to your question relating to the continuation of the PEI Gaming Committee after public statements that it was scrapped in Feb. 2012 please find enclosed the following evidence.

As a result of the Guardian success on their FOIP request and the Privacy order to PEI Government to release the loan documentation we are able to verify the dates that the Gaming Committee received funds. The wires were as follows:

- 1) Dec. 22, 2011      \$700,000.00
- 2) Dec. 18, 2012      \$100,000.00
- 3) Jan. 7, 2013        \$100,000.00

If the Gaming Committee had any intention of paying Simplex, they would have done so on Dec. 22, 2011. They chose not to. Gary Scales continue to mislead Walsh and Simplex for over a year. Scales emails however, do imply that significant work was still being done into 2013 and the wire transfers confirm significant payments.
