I. Legislation and Mandate

The Commission's authority arises from a 1994 amendment to the *Legislative Assembly Act*, which established the independent Indemnities and Allowances Commission for the purpose of reviewing annually the salaries and benefits of MLAs and parliamentary leaders, and reporting decisions and findings to the Speaker by a legislated deadline of December first. A copy of *Legislative Assembly Act*, Section 46, is included in Appendix A.

On October 31, 2007, the Speaker of the House, the Honourable Kathleen Casey, appointed this three-member Indemnities and Allowances Commission to review the salaries and benefits of Members of the Legislative Assembly (MLAs). Appointed to the Commission are Barbara Stevenson, Q.C., Chair of the Commission, Blair Campbell and Leonard Cusack, Commissioners.

II. Introduction

In preparation for writing this report, the Commission published an advertisement in all local newspapers inviting public submissions on the issue of MLA remuneration (a copy of the advertisement is attached in Appendix B). The Commission acknowledges the input of those who made submissions and thanks them for their efforts. These include David Steeves of Charlottetown, Gary A.O. MacKay of Birch Hill, Tom and Kirsten Connor of Charlottetown, and the Association of Former Members of the Legislative Assembly of Prince Edward Island.

As noted in the report of the previous Commission, it has been determined that the MLA pension plan is in need of the Commission's attention. The Commission will address these pension matters in its 2008 report.

As recommended in the Commission's 2006 report, Members of the Prince Edward Island Legislative Assembly receive an annual, fully taxable base salary of \$62,500. This base salary replaced the combined indemnity and non-taxable expense allowance previously assigned to the position of MLA.

III. Research

In determining the salary adjustment, the Commission established the following processes and factors as most relevant:

- i Public input
- ii Analysis of current provincial MLA salary, benefits, and allowances
- iii Examination of previous Commission reports
- iv Comparisons with other provincial MLA remuneration levels
- v Review of Consumer Price Index (CPI)

i. Public input

The Commission decided, as part of the discovery process, to canvass public opinion on the subject of MLA remuneration; this would allow the Commission to hear - and account for - public opinion during its deliberations. Accordingly, the Commission placed an advertisement (see Appendix B) in all local newspapers inviting written public submissions on the subject of MLAs' salaries and allowances as a means of soliciting public opinion.

As noted, the Commission received three submissions and has summarized them as follows:

- MLA salaries be increased according to the national Consumer Price Index (CPI)
- given the recent pay adjustment and transition period of the newly elected government, remuneration and benefits should remain at current levels, and;
- restructure the remuneration review process to eliminate the annual review requirement and make the process more transparent and participatory for the public

The Commission appreciates this input and thanks those who took the time to contribute to the Commission's work.

A presentation was made to the Commission by the Association of Former Members of the Legislative Assembly of Prince Edward Island (Association) on behalf of its membership regarding issues of health and pension benefits. Representing the Association were Norman MacPhee, President; Marion Murphy, Secretary Treasurer; and Pat Mella, spokesperson.

The Association recommended two items for the Commission's consideration:

- that the Province of Prince Edward Island (PEI) adopt some type of co-pay provision of health care premiums for former members, and;
- that the MLA pension plan indexing formula of "CPI minus 2% to a maximum of 8%" be changed to eliminate the "minus 2%" provision, subject to a maximum percentage.

The Commission investigated the option of the Province of PEI adopting some type of co-pay provision of health care premiums for former members. The Commission considered potential financial and administrative consequences of establishing a co-pay provision, and determined such a change will not be made.

As noted in the previous Commission report, and based on information arising from this presentation, the Commission has determined that the MLA pension plan warrants further investigation. The Commission acknowledges the existence of issues regarding the pension plan and will undertake a detailed review of the MLA pension plan in 2008.

ii. Analysis of current provincial MLA salary, benefits, and allowances

The base salary for MLAs is currently set at a fully taxable amount of \$62,500. Additional salaries and allowances are provided for positions such as minister, leaders, presiding officers, and others, and will be detailed later in this report.

Full benefits, including health, dental, pension, group insurance, and life insurance, are provided for MLAs based on the same terms and conditions applied to the Excluded Group of Employees in the Provincial Civil Service. In addition, MLAs receive professional support in the form of staff, communication services, travel allowances, office facilities, and computer hardware to assist in the performance of their duties.

iii. Examination of previous Commission reports

Previous Commission reports dating back to 1994 (the first year the Indemnities and Allowances Commission was legislated into existence) were reviewed by the Commission to ensure continuation of any precedents previously set, and to carry forward any previously-noted issues requiring the Commission's attention.

iv. Comparisons with other provincial MLA remuneration levels

The Commission was fortunate to have at its disposal the *Report to the Members' Services Board of the Yukon Legislative Assembly Respecting MLA Salaries and Benefits*, published in October 2007, by Patrick L. Michael of the MLA Salaries and Benefits Commission. In reviewing the salaries and benefits provided to Yukon MLAs, Mr. Michael conducted a comprehensive survey of remuneration paid to MLAs across the country, compiling the data into comparative tables appended to his report. Given the timeliness of the publication and the succinct presentation of the comparative data, the Commission accepted these findings and included the tables in Appendix C.

In analyzing the data in Appendix C, the Commission notes that Prince Edward Island MLAs are the lowest paid in the country.

v. Review of Consumer Price Index (CPI)

The Commission investigated the application of CPI as a tool for determining salary adjustment.

Supporting documents referred to by the Commission include *Your Guide to the Consumer Price Index, The Consumer Price Index,* and *Consumer Price Index: A Preview of the Upcoming Basket Update,* all publications of Statistics Canada from 2007. The Canada All Items Consumer Price Index Annual Increase is included in Appendix D.

IV. Review

Following is an outline of current remuneration for MLAs, effective May 28, 2007.

V. Decisions

1. The Commission has concluded, based on research presented in this report, that a salary increase of 2% shall apply (as follows), effective April 1, 2008:

Appendix A

Section 46 of the Legislative Assembly Act of Prince Edward Island

Prince Edward Island, Legislative Counsel Office. Legislative Assembly Act, Section 46, R.S.P.E.I. 1988, Cap. L-7.

- **46.** (1) The Speaker, after consultation with such persons as the Speaker considers appropriate, shall appoint an independent commission to be known as the Indemnities and Allowances Commission to review and determine the remuneration and benefits to be paid to the members of the Legislative Assembly, Ministers, the Speaker, Deputy Speaker, the Leader of the Opposition, Government House Leader, Opposition House Leader, Leader of a Third Party, Government Whip and Opposition Whip.
- (2) The Commission shall be comprised of three independent, neutral and knowledgeable persons from private life.
- (3) The persons appointed pursuant to subsection (1) shall serve until appointment the dissolution of the Assembly during which they are appointed, or for a maximum of five years, and are eligible for reappointment.
- (4) On the resignation, inability to act or death of a commissioner, the Speaker shall appoint a replacement.
- (5) The persons appointed pursuant to subsection (1) have all the powers and privileges and immunities of a commissioner pursuant to the Public Inquiries Act R.S.P.E.I. 1988, Cap. P-31.
- (6) The Commission, annually and at such other times as the Speaker may request, shall carry out a review of remuneration and allowances paid to the persons referred to in subsection (1), and shall on or before the first day of December of each year deliver a report to the Speaker which shall be final and binding.
- (7) The Speaker shall, within five sitting days of the commencement of the Legislative Assembly next following the receipt of the report, cause a copy thereof to be laid before the Legislative Assembly.
- (8) The report shall, from such date as may be specified therein, have effect for the purposes of determining the remuneration and allowances of the persons referred to in subsection (1) as if the provisions contained in it had been enacted by the Legislative Assembly.
- (9) For the purposes of this section, remuneration and benefits include salaries, indemnities, allowances and pension benefits. 1994,c.34,s.5; 1997,c.28,s.3.
