He served as Attorney General, Minister of Education, Minister of Tourism, Minister Responsible for the PEI Liquor Control Commission and Minister Responsible for the Prince Edward Island Human Rights Commission. Lantz was also the vice-chair of the legislative review committee. Lantz ran unsuccessfully in the 18 November 1996 general election.

After attending West Kent Elementary and Queen Charlotte Junior High Schools, Lantz graduated from Colonel Gray Senior High School in 1979. She also chaired the community consultative committee and the Cabinet committee on social policy reform.

Lea received her early education in Moncton-area schools before receiving a Bachelor of Science with Honours in Biology from Mount Allison University in Sackville, New Brunswick. Following university, Lea attended Holland College in Charlottetown where she earned a diploma in weaving in 1975. From 1973 to 1976, she worked as a substitute teacher in Charlottetown and as a craftsperson. In 2002, she became a consultant in strategic planning, project management and research.

She served as a director of the Canadian School Boards Association, president of the Prince Edward Island School Boards Association, and sat on the Prince Edward Island Industrial Relations Committee, the Human Resource Development Committee and the Provincial Task Force on Education. Lea has also served as director of the education foundation "Kids Count – The Learning Fund" and as project co-ordinator for two Staying Smoke Free videos. She is a former president of the Heart and Stroke Foundation of PEI and served as a director of the Heart and Stroke Foundation of Canada.

Lea and her husband reside in Charlottetown. In their retirement, they sailed their 41-foot sailboat throughout the Bahamas and the western and central Caribbean. LeClair, a Liberal, was first elected to the Legislative Assembly in the general election of 28 May 2007 for District 27 Tignish-Palmer Road. On 12 June 2007, he was appointed Minister of

Agriculture. He served in that portfolio until 13 January 2009 when he was named Minister of Fisheries, Aquaculture and Rural Development. He also served as a member of the Treasury Board and vice-chair of the legislative review committee. LeClair was defeated in the 3 October 2011 general election by the then-Progressive Conservative Hal Perry†. In the general election of 4 May 2015, LeClair announced his intention to again seek the Liberal nomination in District 27, Tignish-Palmer Road, but was defeated by Perry after losing the majority of the 282 ballots cast on nomination night.
