He had run unsuccessfully in the 29 March 1993 election.

MacDonald, a Progressive Conservative, was first elected in the general election of 1982 for 4th Queens. Though re-elected in the general election of 1986 for 4th Queens, he lost in 1989 and 1993. He was elected again in the general elections of 1996, 2000 and 2003 to represent the newly formed electoral district of Belfast-Pownal Bay. In 1982, MacDonald was chair of the Progressive Conservative caucus, and in 1983 and 1984 chair of the legislative committees on agriculture, fisheries, tourism and industry. On 2 December 2010, he was honoured in the Legislature for 25 years of service, as Premier Robert Ghiz† acknowledged that he had held more titles than any other MLA in the Legislature.

He served on committees dealing with Public Accounts, agriculture, transportation and public works. In the 2000 election, the Progressive Conservatives took 26 seats and the Liberals only

one. MacKinley was the lone Liberal member in the Legislature. Following the election, he became interim Leader of the Liberal Party and Leader of the Opposition.

On 12 June 2007, MacKinley was named Minister of Transportation and Public Works, which was renamed Minister of Transportation and Infrastructure Renewal on 13 January 2010. He became Minister of Fisheries, Aquaculture and Rural Development on 18 October 2011. MacKinley was only defeated once, in the general election of 1982 in 2nd Queens. MacKinley announced on 10 February 2015 he would resign his seat after serving as an MLA for 29 years.

MacKinley received his primary education at the school in York Point and later attended Charlottetown Rural High School. He is a farmer who grows potatoes at MacKinley Farms and also is a partner in MacKinley Brothers Beef Farm, where he raises cattle. In the past, MacKinley raised hogs, operated a dairy farm and ran a snow removal business.

He served as the director of the Prince Edward Island Federation of Agriculture, the Prince Edward Island Farm Centre and the Prince Edward Island Potato Processing Council. MacKinley was a member of the Canadian Horticultural Council Labour Board and the Queens County chair of the Prince Edward Island Potato Producers Association.

In 2010, MacKinley was awarded MADD Canada's Citizen of Distinction for his contributions toward the anti-drinking and driving movement.

MacKinley and his wife live on the family farm in North River. Ann MacKinley is the daughter of Bert and Catherine Clarkin from Lot 65.

MacKinnon, a Progressive Conservative, was first elected to the Legislative Assembly in the 18 November 1996 general election for District 15 Winsloe-West Royalty. He won re-election in 2000 and served as Minister of Transportation and Public Works 1 May 2000 to 14 November 2000. He also served on the Treasury Board, the Executive Council and the legislative review committee. In 2003, MacKinnon chose not to reoffer and Progressive Conservative Wayne Collins† was elected in the district.

MacKinnon attended West Royalty, Charlottetown Rural, Saint Dunstan's High School, Saint Dunstan's University, Prince of Wales College and University of Prince Edward Island. He also attended the Provincial Vocational Institute for one year while attending UPEI. MacKinnon also studied architecture at the Nova Scotia Technical College.

MacKinnon currently works as an architect and resides in West Royalty.

MacLauchlan, a Liberal, was elected to the Legislative Assembly in the 4 May 2015 general election for District 9 York-Oyster Bed. He was sworn in as Premier of Prince Edward Island and President of Executive Council on 23 February 2015. He served as Minister of Finance for a brief period of time. He also served as the Minister of Justice and Public Safety and Attorney General, Minister Responsible for Intergovernmental Affairs, Minister Responsible for Aboriginal Affairs, and Minister Responsible for Acadian and Francophone Affairs.

Raised in Stanhope, MacLauchlan attended primary school in Stanhope before attending Charlottetown Rural High School. He then graduated from UPEI with a Bachelor Degree in Business Administration in 1976. In 1981, he graduated from the University of New Brunswick with a Bachelor of Law (LL.B) and from Yale University with a Master of Law (LL.M) in 1983. Prior to his time in the Legislative Assembly, MacLauchlan served as a councillor in the community of North Shore, and as the director of the Federation of PEI Municipalities. He has also served as UPEI President and Vice-Chancellor from 1999 to 2011 and as President Emeritus since 2012.

MacLauchlan was chair and a board member of the Medavie Health Foundation from 2009 to 2014, and director of the Windsor Foundation from 2012 to 2014. He was previously the Dean of Law at the University of New Brunswick and a professor of law at Dalhousie University. He authored the political biography of Alex B. Campbell, Prince Edward Island's longest-serving premier, entitled *Alex B. Campbell: The Prince Edward Island Premier Who Rocked the Cradle*.

MacLauchlan was named to the Order of Canada in 2008 and to the Order of Prince Edward Island in 2014. He has extensive community involvement, including co-chairing the Georgetown Conference and serving on the boards of several large philanthropic foundations.

He and Duncan reside in West Covehead. Duncan was born on 21 December 1956 in St. Andrew's West, Ontario.

MACLEOD, HECTOR LAWRENCE, carpenter, fisher, farmer, realtor and contractor; b. 30 June 1944 in Ingonish, Nova Scotia, son of Walter MacLeod and Julia Hardy; m. 16 September 1967 to Elizabeth Campbell, and they have two children, Sherri and Patti.

MacLeod, a Liberal, was first elected to the Legislative Assembly in the general election of 1993 for 1st Prince. He was re-elected in the general election of 1996 for the new electoral district of Alberton-Miminegash. He was defeated in the general election of 2000. MacLeod was a member of legislative committees dealing with agriculture, forestry, environment, fisheries, intergovernmental affairs, transportation and Public Accounts. In 1997, he was appointed chair of the Liberal caucus and party whip. MacLeod served as opposition critic for forestry, fisheries and the environment from 1996 to 2000.

Since his time in public office, MacLeod has served as chair of the Western Hospital Foundation's board of directors. He was named chairman of the Prince Edward Island Liquor Control Commission in September 2009.

MacMillan, a Progressive Conservative, was elected in the 17 April 2000 general election for District 12 Charlottetown-Kings Square defeating Richard Brown† by 18 votes. He ran unsuccessfully in the 29 September 2003 election, losing to Brown by 142 votes. MacMillan served as a committee member on legislative review, as a member of the strategic planning committee on community and social policy, and chair of the standing committee on social development.

Prior to running for public office, MacMillan attended Colonel Gray Senior High School and studied arts at UPEI. He played in the National Hockey League (NHL), was a hockey coach in Charlottetown and was drafted 15th overall in 1972 by the New York Rangers. He won the Lady Byng Memorial Trophy for his best season in1978–1979, where he scored 37 goals and added 71 assists in 77 games for 108 points for the Atlanta Flames, later known as the Calgary Flames. He earned 577 total career points in 753 NHL games, putting him third all time among Prince Edward Island players. He also played for the St. Louis Blues, the Colorado Rockies (later known as the New Jersey Devils) and the Chicago Blackhawks. His nickname was "Mack the Knife." He is the younger brother of former NHL player Billy MacMillan. He also owns a bar in Charlottetown called the Sport Page and also the Page II Pub and Grill, formerly known as Harbour Bridge Restaurant and Sports Bar in Stratford.

MacPherson, a Liberal, was first elected to the Legislative Assembly in the general election of 1986 for 4th Queens. He was re-elected in the general elections of 1989 and 1993. MacPherson was defeated in the general election of 1996 in the new electoral district of Belfast-Pownal Bay. On 21 May 1996, he was appointed Minister of Provincial Affairs and Attorney General. While a member, MacPherson served as chair of the intersessional committee on human rights, and vice-chair of the Public Accounts committee. October 2011. McGeoghegan was appointed Government Whip in January 2010. He was also named Minister of Justice and Public Safety and Attorney General, and until 15 November 2011 when changes were made to the Executive Council and ministries, he remained Minister of Education and Early Childhood Development.

He also served as Minister of Transportation and Infrastructure Renewal from February 2015 to May 2015. McIsaac was re-elected in 4 May 2015 general election, winning his seat by two votes after a judicial recount for District 5 and a tie of 1,173 votes was confirmed. McIsaac won his seat by a flip of a coin. This was the first time a coin toss was done to break a tie and elect a Member of the Legislative Assembly of Prince Edward Island. McIsaac was named the Minister of

Agriculture and Fisheries and Government House Leader under the MacLauchlan† administration. On 10 January 2018, McIsaac resigned his ministry but remained a Member of the Legislative Assembly.

He has served as committee chair on agriculture, environment, energy and forestry and on the Cabinet committee on priorities; and a member of committees dealing with agriculture, environment, energy, forestry, education, innovation, fisheries, intergovernmental affairs, transportation and Public Accounts.

Raised in Mermaid, McIsaac received his education at Mermaid School, Fort Augustus Consolidated School and Charlottetown Rural High School, from which he graduated in 1972. He went on to study science at UPEI and Nova Scotia Agricultural College. McIsaac worked as a dairy farmer and small business operator.

McIsaac has held many leadership roles in the dairy industry, serving as chair of the provincial Milk Marketing Board, as Atlantic Canada director on the board of Holstein Canada and on the executive of the PEI Federation of Agriculture. He has also been involved in his community, working with the Home and School Associations of Glen Stewart and Charlottetown Rural, the Cross Roads Community Fire Department, the Pownal Rink Association, Farmers Helping Farmers, Habitat for Humanity and various church committees.

McIsaac and his wife reside in Websters Corner. Joanne was born on 21 March 1955 and is the daughter of Hendrick John Kamphuis and Willemina Enserink of Alexandra.

He ran unsuccessfully in the 28 May 2007 election. McKenna served on committees dealing with social development, Public Accounts, the Constitution of Canada and Treasury Board.

McKenna attended St. Teresa's Consolidated and graduated from Morell Regional High School in 1974. He studied at UPEI and received a Bachelor of Science in biology, after which he attended the University of Waterloo, graduating in 1982 with a Doctor of Optometry (OD) degree. He opened a small practice after his graduation and was a founding partner of the Family Vision Centre in Charlottetown.

McKenna served in various capacities on many boards including Queen Elizabeth Foundation, University of Prince Edward Island Board of Governors, Stratford Area Watershed Improvement Group, PEI College of Optometrists, PEI Association of Optometrists, Our Lady of Assumption Parish Council and Property 1 Finance Committee. McKenna also served with the

provincial Progressive Conservative Party on its fundraising committee and as an executive member of the federal Cardigan Progressive Conservative Association.

McKenna died suddenly in Queenstown, New Zealand, on 19 March 2014. He was 57. Elizabeth McKenna was born 2 February 1958 in Charlottetown and is the daughter of Frank Lawrence Butler and Mary Ann Jean MacIsaac.

MELLA, M.A., PATRICIA "PAT" JANET, educator; b. 29 August 1943 in Port Hill, daughter of Frank Joseph McDougall and Patricia Mary Hilda Callaghan; m. 27 June 1970 Angelo Mella, and they have three children, Andrew, Michael and Nancy; Roman Catholic.

Mella, a Progressive Conservative, was first elected to the Legislative Assembly in the general election of 1993 for 3rd Queens. She was elected again in the general election of 1996 for the newly formed district of Glen Stewart-Bellevue Cove, winning re-election in the general election of 2000. Mella was previously defeated in the general election of 1989 for 3rd Queens. Elected leader of the Progressive Conservatives on 10 November 1990, Mella became the first woman in the province's history to be named leader of a political party. She had no seat within the Legislative Assembly until 1993 when she became the only Progressive Conservative member in the 31-seat Legislative Assembly. Mella resigned as Leader of the Progressive Conservative Party on 1 December 1995 but remained as leader of the opposition. On 27 November 1996, she was appointed Provincial Treasurer and Minister Responsible for the Status of Women in the government of Premier Pat Binns •. She served as Provincial Treasurer until 2003 and did not reoffer for another term.

Following her time in public office, Mella was appointed as co-chair on Prince Edward Island's Progressive Conservative campaign for the federal election in 2004. She was named the PEI Director of the Atlantic Lottery Corporation in 2005 and was serving as vice-chair of the Board of Directors in 2012. Mella became a member of the Board of Management of the Canadian Revenue Agency in 2006. She was named to the Board of Governors for UPEI. In 2008, she was named Public Kindergarten Commissioner to guide the transition of kindergarten into the provincial public school system by 2010. Mella was appointed to a three-person board of the Public Schools Branch, on 23 August 2016, which was tasked with making decisions based on a school review released January 2017 that recommended closing five Island schools.

Mella received her elementary school education in Bloomfield and obtained a high school diploma in 1961 at Kinkora High School. She attended Saint Dunstan's University where she obtained a Bachelor of Arts in 1965 and a Bachelor of Education in 1973. Mella also attended the Catholic University of America in Washington, DC, where she earned a Master of Arts in medical sociology in 1967. She returned to Canada and accepted a position as a lecturer at St. Patrick's College, Carleton University, from 1967 to 1970 and at Queen's University in Kingston from 1970 until 1972. In 1979 she and her family moved to the Island where she taught political science and English in various schools. In 1987, she obtained a teaching position at Charlottetown Rural Regional High School where she remained until she became Leader of the Progressive Conservative party.

On 18 February 2005, she received a Distinguished Alumni Award from UPEI, which also awarded her an honorary doctorate of law degree in 2015. In 2011, Mella completed the Directors College program through McMaster University and received the Chartered Director (C. Dir), certified corporate director, designation.

She has served on committees relating to education and professional development through the Prince Edward Island Teachers' Federation. Mella is a past-president of the Charlottetown Christian Council and was a member of the Diocesan Pastoral Council for the Roman Catholic Diocese of Charlottetown.

MILLIGAN, KEITH WAYNE, teacher, farmer, realtor; b. 8 February 1950 in Inverness, son of Charles Bayfield Milligan and Reby Hazel MacKinnon; m. 11 August 1978 Deborah Foley, and they have three children, Charles "Christian," Olivia and Dustin; Anglican.

Milligan, a Liberal, was first elected to the Legislative Assembly in a by-election held 2 February 1981 for 2nd Prince. He was re-elected in the general elections of 1982, 1986, 1989, 1993 and 1996. In the 1996 election, he represented the new electoral district of Cascumpec-Grand River. Following his by-election victory on 2 February 1981, Milligan was selected interim leader and served as Leader of the Opposition until Joseph Ghiz* won the leadership convention held 24 October 1981. From 1982 to 1986, Milligan served as the opposition critic for education. When the Liberals formed the government in 1986 he was appointed Minister of Health and Social Services and Minister Responsible for the Hospital and Health Services Commission. From 1989 to 1992, he served as Minister of Agriculture. In 1993, he was appointed Minister of Education and Human Resources. From June 1994 to 1996, Milligan was Minister of Transportation and Public Works. Following the departure of Catherine Callbeck* from provincial politics in 1996, Milligan was elected leader of the Liberal Party.

On 10 October 1996, Milligan was sworn in as the 29th Premier of Prince Edward Island. However, the Liberals were defeated in the general election of 18 November 1996 by the Progressive Conservatives and their newly elected leader Pat Binns•. After 20 years in the Legislature, Milligan resigned his seat on 3 March 2000, but continued his duties in the House until the session closed on 17 March 2000.

Following his tenure in the provincial Legislature, Milligan threw his hat into the federal political ring in 2007 when he ran for the Liberal nomination in Egmont. While Robert Morrissey• originally won the bid in November 2007, he later stepped down from the position allowing Milligan to take up the Liberal flag by acclamation. Milligan lost the electoral bid to Progressive Conservative Gail Shea† by 62 votes. He ran unsuccessfully in the 14 October 2008 federal election.

Milligan received his early education in his native community at the Inverness District School. He later attended O'Leary High School and was valedictorian of his graduating class in 1970. Milligan then continued his studies at UPEI where he earned Bachelor of Arts and Bachelor of Education degrees. Following the completion of his education he worked as a teacher for two years

in Regional Administrative Unit One. He was a silver fox and elk rancher and served as manager of the West Prince Regional Services Centre. Currently, Milligan works as a realtor for Royal LePage in Summerside.

He has been involved in numerous community projects and initiatives, including the Tyne Valley Oyster Festival. Milligan has served as vice-president of the Tyne Valley Fire Hall, secretary and fundraising chair for the Tyne Valley Community Sports Centre, secretary of the Stewart Memorial Health Centre and member of the West Prince Community Advisory Board, the Canada Fox Breeders Association and Prince Edward Island Fur Breeders Association.

Mitchell, a Liberal, was first elected to the Legislative Assembly in the 28 May 2007 general election for District 10 Charlottetown-Sherwood and was re-elected on 3 October 2011. Mitchell was re-elected in 4 May 2015 general election and named the Minister of Communities, Land and Environment under the MacLauchlan† administration. On 10 January 2018, Mitchell was named Minister of Health and Wellness following a Cabinet shuffle. He has served on committees dealing with fisheries, intergovernmental affairs, transportation, community affairs, economic development, education, innovation, health, social development, seniors and Public Accounts. Morrissey, a Liberal, was first elected to the Legislative Assembly in the general election of 1982 for 1st Prince at the age of 27. He was re-elected in the general elections of 1986, 1989 and 1993. Morrissey was elected in the general election of 1996 in the new electoral district of Tignish-Deblois. Overall, he served for 18 consecutive years in the PEI Legislature.

On 2 May 1986, he was appointed Minister of Transportation and Public Works. On 22 June 1989, he became Minister of Industry. On 15 April 1993, Morrissey was appointed Minister of Economic Development and Tourism and the minister responsible for Enterprise PEI. Following the 1996 general election he held the positions of opposition house leader and finance critic. Over the years, Morrissey also served on various standing committees dealing with privileges, rules and private bills, and community affairs and economic development. He chaired the Public Accounts committee. After 18 years in office, Morrissey left the public eye in 2000, choosing instead to operate a manufacturing business supplying the mass transit industry.

She has served on the standing committee dealing with agriculture and fisheries; communities, land and environment; education and economic development; infrastructure and energy; and the Standing Committee on Rules, Regulations, Private Bills and Privileges. On 20 May 2015, Mundy was appointed Minister of Education, Early Learning and Culture and the Minister Responsible for the Status of Women.

Murphy taught at various Island schools for 13 years and was a school secretary for 14 years. She was actively involved in the family farm and sawmill operation in Millvale with her husband.

She has served as president of the Provincial Home and School Association and as vice-president of the Canadian Home and School Association, Eastern Region. On 8 April 2006, she was awarded a life membership in the Prince Edward Island Home and School Federation Inc. for outstanding service in the provincial federation. Murphy was instrumental in the founding of the Small Farms Advisory Board, was a charter member of the Central Queens Funeral Co-operative, a 4-H leader and a Red Cross worker.

Murphy and her family are members of the Saint Anne's Roman Catholic Church where she serves as CWL member and on various committees. In the Association of Former Members of the Legislative Assembly of Prince Edward Island, Murphy has served as president, secretary and on various committees including the monument committee. This committee has erected monuments at Charlottetown cemeteries honouring premiers who have passed but whose monuments did not recognize that they had been premier.

Myers was chosen as interim leader of the PEI Progressive Conservative Party on 31 January 2013, following party leader Olive Crane's† resignation, and he became the Official Leader of the Opposition on 11 February 2013 and held this position until October 2015.
