YEO, HONOURABLE JOHN, farmer and merchant; b. 29 June 1837 in Port Hill, son of Honourable James Yeo and his second wife, Damaris Sargent, of Kilkhampton, England;

Anglican; d. 14 December 1924 in Port Hill.

Yeo, both a Liberal and a Conservative, was first elected to the House of Assembly in the 1858 general election for 2nd Prince as a Conservative. He was re-elected in the general elections of 1859, 1863, 1867, 1870, 1872, 1873, 1876, 1879, 1882, 1886, and 1890. Yeo was appointed to Executive Council in 1870. He was elected Speaker in 1871, a position he held when the Island entered Confederation in YEO, JAMES, merchant, shipbuilder, and ship 1873. In that year, Yeo was appointed to Executive owner; b. 31 October 1827 in Port Hill, son of Council, and was reappointed in 1876 as a member of the Free Schools Party coalition led by L. H. Davies*. YOUNG, CHARLES FRANK ROSS "JOHNNY,"

businessperson; b. 1 September 1931 in Red Point, son of Major Ralph Young and Nellie Mossey; m. 27 July 1955, Helen MacLean of Kingsboro, and they had four children, Bonnie, Lynda, Ross*, and Shelley; Baptist; d. 7 March 1990 in Red Point.

Young, a Liberal, was first elected to the Legislative Assembly in the general election of 1978 for 1st Kings. He was re-elected in the general elections of 1979, 1982, 1986, and 1989. He served as Deputy Speaker and Party Whip. In 1986 Young was appointed Minister of Fisheries, and served in this Ministry until 1989. The position meant a great deal to Young, as his family had a strong background in the fishery. In 1990 Young served constituents from his bedside, until only hours before his death from cancer. In the by-election held after his death, his seat in the Legislature was filled by his son Ross, who served in the Legislature until 1996.

Young, or "Johnny," as he was called, received his education in Red Point, North Lake, and Montague, following which he spent a few years working in Montague and Toronto. In 1952 he returned to Red Point where he began operating an Esso Service Station. Young was a farm equipment dealer for Massev Ferguson. He also operated a service station in Souris for a number of years. In 1970, Young, along with his wife, and his and Restaurant in Kingsboro.

Along with numerous political and business involvements, Young was involved in his comdent of the Eastern Kings Community Improvement Committee and a founding director of the Eastern Kings Fire Department. Young, a Liberal, was first elected to the Legislative Assembly in a by-election held 18 March 1991 for 1st Kings. He was re-elected in the general election of 1993. He was defeated in the general election of 1996 in the new electoral district of Souris-Elmira. The 1991 by-election was called due to the death of Young's father, "Johnny" Ross Young, who represented 1st Kings from 1978 to 1990. In 1994 Young introduced a private member's bill which laid out the current electoral districts first used in the 1996 general election.

Young received his early education at Souris Regional High School. In 1984 he graduated with a Bachelor of Arts degree from Mount Allison University in Sackville, New Brunswick. During his time at Mount Allison, Young played on the football team. He was an AUAA all-star, a CIAU all-star, and served as co-captain and assistant coach of the team. Following university, he managed a Wacky Wheatley's store, one of Atlantic Canada's largest electronic and carpet retailers. In 1989 he joined the Atlantic Television Network as an account executive in Saint John. In 1991 he attended the University of Prince Edward Island. Young is currently a financial advisor with Freedom 55 Financial in Charlottetown.

Young was a member of the Kings County sister Doris, began operating the Sea Breeze Motel Exhibition Association, the Souris Ski Club, and the Souris Curling Club. He coached the Eastern Kings Wildcat football team and was a board member of the Prince Edward Island Tackle Football munity. He served as a trustee of the Red Point Program.
