To complete this nomination, you will need the following:

- biographical summary for nominee (do not submit a résumé)
- three letters of support (excluding you, the nominator)
- · contact information for the three letter of support writers

The number of pages attached to the nomination should not exceed is ten, one-sided, letter-sized pages.

Nominations for each award year close on the third Wednesday in March 19, 4:00 p.m.

Please ensure that:

- all questions are answered, as an incomplete nomination package may result in your nominee not being put forward for consideration
- all attachments are included with your nomination
- your nomination package is received before the closing date

Please do not:

- tell the nominee about the nomination
- submit a resumé or cv for the biographical summary
- submit more than 10 single-sided, letter-sized attachments
- contact OPEI Advisory Council members to advocate for your nominee
- organise additional letters of support for your nominee or ask others to also submit nomination packages for your nominee

Letters of Support

Provide three letters of support from three different people, along with their contact information.

Ask your three letter of support writers to provide their personal experience of your nominee and how they believe your nominee embodies the spirit of the Order.

This could be the effect the nominee had on them or someone else, their effect on their community, their profession or on Island culture.

As the nominator, you are excluded from providing a letter of support.

These letters should be no more than 500 words, (two single-spaced, letter-sized pages), each. Please attach each of these letters to the nomination form, labeled as "Letter of Support 1", "Letter of Support 2", and "Letter of Support 3."
